It was the largest flood caused by a DANA in the 21st century in our country, comparable to other historic events that occurred in the Valencian Community during the 1950s and 1980 s.







Figura 10 Precipitaciones acumuladas el día 29 de octubre de 2024 en España. Fuente: AEMET







Mapa de los acumulados de lluvia el martes 29-10-2024 (Infografía: Inforatge)





Figura 4 Hietograma areal e hidrograma en la cuenca vertiente a estación de aforos del SAIH. Fuente: SAIH de la CHJ



In Spain, it is evident that preventive measures and Automatic Hydrological Information Systems (AHIS) to assist in flood prediction and management, as well as the National Flood Zone Mapping System, which covers potentially floodable areas, as well as the PROTOCOLS for addressing flood disasters, urgently require updating and equipping them with more reliable and secure technological means.



# Summary of PROPOSALS and INITIATIVES put forward by the CLEAN WASTE Cluster following the Conference held from January 7 to 11, 2025



Following an urgent analysis and study of the current status of the waste generated (goods collected from the streets of the affected towns and from affected vehicles) accumulated in the various collection areas, and after four days of visits to the affected areas by Cluster technicians and a German consultancy firm, we verified that the following situations occurred in the management of the waste accumulated mainly on the streets of the affected towns:

After the houses were emptied, carried out mainly by volunteers and staff, residents'
belongings accumulated in the middle of the streets, diverting much of the mud into
the sewers, causing serious blockages and making it impossible to pump out water
from garages.

 The affected vehicles, which were mainly on the streets and in garages in the towns, were removed by inappropriate means, causing damage to the vehicles to a greater extent than the damage caused by the flood. The vehicles were not identified beforehand to inform the owners.

Our PROPOSAL was born as a professional sector related to WASTE MANAGEMENT.









These PROPOSALS are designed with a FUTURE-LOOKING vision, helping to turn the effects of tragedies like those experienced in Valencia into a source of information and assistance for other regions or countries that may experience similar situations.



# Summary of PROPOSALS and INITIATIVES put forward by the CLEAN WASTE Cluster following the Conference held from January 7 to 11, 2025



- 1. After assisting victims and providing them with basic services (food, water, medicine, energy, communications), the most important thing, given the scale and economic, environmental, and social impact, is to ensure proper and flexible management of the waste generated by a disaster.
- 2. Given the risks of the work to be carried out after these disasters and considering the safety of those affected, volunteers must have an ID issued by a public entity and receive minimal training prior to participating in the work. They must be provided with appropriate protective equipment for the work to be performed. Priority should be given to assisting people in need by providing them with food, medicine, or providing support.
- 3. After carrying out EMERGENCY waste removal actions (which should be limited to the shortest possible time), the procedure must be changed, and a specialized waste management process must be implemented.
- 4. Waste management must always adhere to sustainability and circularity criteria to minimize the environmental impact of these types of disasters, which requires unique and specialized PROTOCOLS, PLANNING, and COORDINATION.
- 5. For proper waste management, it is necessary to develop proven procedures, relying from the outset on specialized entities and/or companies, depending on the type of waste to be treated. This procedure must be carried out in the designated final collection areas and at the appropriate time, for which these measures must be in place.
- 6. Experience shows that the resources required to properly manage waste will be greater in terms of human resources and machinery than initially estimated, as well as adequate spaces for accumulation for subsequent treatment.
- 7. From the outset, the treatment of vehicles accumulated on the streets must be carried out in a manner that allows for: Identification of the owner by license plate and/or chassis number; informing the owner of its destination and condition (via photo), and generating databases. and ensuring that the removal does not cause any further damage to the vehicle than the damage caused by the disaster.
- 8. After their initial removal, vehicles should NOT be handled (as has also been the case in areas near towns) without first removing hazardous waste (fuel, oil, batteries, etc.) due to the safety and health risks they pose.



# Other PROPOSALS and INITIATIVES put forward by the CLEAN WASTE Cluster following the Conference held from January 7 to 11, 2025



Given that many of **the homes and businesses** located on ground floors in the affected towns are rendered uninhabitable by the damage they have suffered, **we understand that they have also become "waste."** 

These properties were the best and most sought-after in these towns,

but after the catastrophe, their value has fallen to ZERO or minimal.

Nine months later, all owners now know that the compensation

payments will NOT allow them to cover the costs of their rehabilitation.

Therefore, we propose that **public agencies should treat the owners** 

of buildings damaged by the DANA with the same criteria as public buildings



and infrastructure (i.e., covering 100% of the value of the damage), given that the residents <u>HAVE NO RESPONSIBILITY for the</u> causes and reasons that led to this catastrophe.

The DANA has taken EVERYTHING from those affected (their memories, possessions, vehicles, and even their homes).

"We must return as much value as possible to them."



### Proposal to establish a PROFESSIONAL SUPPORT SERVICE for affected owners



For those owners who can afford the renovation of their properties with their own resources and subsidized resources, we propose establishing a PROFESSIONAL SUPPORT SERVICE, the costs of which will be borne by the public entities.

- Manage, through the owners' delegation, the permits to begin the renovation process for their properties with the relevant entities and organizations.
- Obtain various BUDGETS for the renovation, comparing their quality/price ratios, and establishing and pre-arranging with potential suppliers the appropriate guarantees for the execution of the work to be carried out, doing so under the best price/quality conditions and guarantees that protect the owners' interests.
- Monitor and supervise the renovation work, ensuring that technicians maintain and execute it properly and within budget.
  - Process the necessary procedures until the completion of the renovation work, as well as obtain administrative authorizations for the new use of your home or business premises, as well as all licensing, permit, and registration processes.
  - And, where appropriate, advise on the processes for the RENTAL/TRANSFER of the property and/or SALE, if required.





### SUSTAINABLE RECONSTRUCTION of damage caused by DANA IN PUBLIC PROCUREMENT



We also propose the USE in PUBLIC PROCUREMENT of materials from waste, (e.g. plastics, rubbers, debris, ...) minimising their deposit in landfills and/or incineration.

Avoiding that in these public tenders the PRICE is the main criterion for grading, (an issue that the current regulations (Law 7/2022 or LCAP) already establish, having to consider, for example, the cost of the useful life of the products, or considering minimizing the costs of landfilling.

The application of CIRCULAR ECONOMY in PUBLIC PROCUREMENT is still not contemplated in any EE:PP contracting in Spain.

We propose that all recoverable waste can have a new use and/or an economic return can be obtained from it, generating a new transformation industry and the generation of new jobs, if possible, a significant part of them inclusive.

The criteria for defining actions to reduce flood risk in the basins of the Pozalet, Saleta, and Rambla del Poyo ravines are as follows:

- a) Zero risk does not exist, so actions are proposed with the aim of achieving acceptable risk levels. This means that flood levels and velocities in the most vulnerable areas should cause the least possible damage during extraordinary floods, such as those that occurred during the DANA.
- b) The solutions proposed to reduce hazards in the most vulnerable areas should not significantly increase the risk in other, less vulnerable areas.
- c) Nature-based solutions will be prioritized. When structural solutions are proposed, they must be supported by favorable cost-benefit studies, seeking greater environmental compatibility and landscape integration.
- **d)** The work being carried out in the Pozalet and Saleta ravines, as well as in the Poyo ravine, must begin downstream, but it should be noted that an adequate level of protection will only be achieved with upstream work.

### Improving knowledge about flood risk




The flooding that occurred on October 29 has highlighted the need to review flood risk planning and develop new hazard and risk maps for this area, as well as mapping flood zones in unstudied sections. This is intended to increase territorial coverage and, most likely, to expand coverage in other areas of the Mediterranean basin, where studies already conducted by the CEDEX Hydrographic Studies Center indicate that maximum rainfall and flow rates for high return periods are underestimated.

#### **Protective Measures** Investment required for prevention and protection measures: €530 million

The main objective of protective measures is to reduce risk by reducing hazards. They include nature-based solutions, such as hydrological and forest restoration and reforestation, controlled storage areas, and channel improvements and structural interventions, such as diversions and greenways, protective mounds, and improved cross-drainage of communication routes. Urgent measures have already been initiated and are planned for implementation during 2025 and 2026.



### Immediate Response Plan to DANA, an investment of €10,600,000 to cover needs such as:

- Extraordinary Temporary Disability: For workers and self-employed workers who have suffered physical or psychological injuries as a result of the DANA (National Emergency Situation). 75% of their salary is guaranteed from the first day.
- · Assimilation of pensions to occupational accidents
- Supplement to the Minimum Living Income (IMV): A 15% supplement to the IMV (Minimum Vital Income) and non-contributory pensions is established.
- Cessation of activity benefit for self-employed workers: Those affected by the DANA (National Emergency Situation) who have been forced to suspend their activity.
- Exemptions from social security contributions: A "zero cost" is established for social security contributions for companies and self-employed workers on ERTE (Temporary Employment Regulation File) directly affected by the DANA

On 29 May 2025, the Vice President and Minister for Ecological Transition and the Demographic Challenge, Sara Aagesen, presented to the associations of victims of the DANA in Valencia a plan to improve the resilience to flooding of the affected territory with an investment of **530 million euros.**
